

# Message from the COE Program Leader

Established within the context of the 21st Century Centers of Excellence (COE) Program by the Ministry of Education, Culture, Sports, Science and Technology, and the Japan Society for the Promotion of Science, the principal objective of the *Gender Law and Policy Center* (GELAPOC) has been to promote research on a wide variety of gender issues in order to bridge the gap between theory and practice within diverse legal, political and public policy processes.

Among other contributions, the Center functions as a library, possessing over 4000 books concerning gender, law and public policy, and moreover, it serves as a networking and information hub that promotes collaboration amongst scholars, researchers and decision-makers in Asian, European, and North American academic institutions, local governments and Bar Associations.

The Center's work focuses on six research themes or "clusters", including: political participation, employment, family, sexuality, human security, and education policy, each of which fit within three conceptual approaches, notably, that of "Theory", "Applied Research", and "Policy Solutions". This multidisciplinary and inter-sectional structure has created a dynamic context for research and intellectual inquiry. We have endeavoured to host over thirty seminars each year, featuring a broad array of Japanese and international speakers with expertise on gender issues. We have also hosted several national and international conferences and symposiums in Sendai (September and November 2004, July 2006, July 2007), in Kobe (June 2005), in Paris (September 2005), and in Tokyo (February 2006).

Additionally, publishing the results of leading research on gender issues is also a vital part of the Center's activities. Since the launch of the Center, we have produced quarterly newsletters, as well as Annual Reviews in both Japanese and English, which are distributed to a number of academic and practical institutions. We have also completed a 12 volume series of books on gender, law and policy-related issues.

The above-mentionned activities have focussed on the legal and political factors impacting upon a complex range of gender issues, and has thereby enabled the Centre of Excellence Program and the *Gender Law and Policy Center* to make unprecedented contributions to knowledge and public policy solutions in the service of gender equality.

The remarkable progress of our Center over the past 5 years has been achieved thanks to the close collaboration with local public organizations, professional lawyers associations, as well as with universities and research institutes from around the world. We will continue to work to establish GELAPOC as one of the best research centers on gender, law and policy issues. We wish to convey our sincerest gratitude to all those who have contributed to these successes for their generous support and cooperation, and moreover, we look forward to collaboration with you on related projects in the future.



Constitutional Law and Gender



The 21st Century Centers of Excellence (hereafter, COE) Program is a national government initiative that aims to advance innovative research on humanity via the natural and social sciences. As a means of pursuing the full implementation of the "The Basic Law for A Gender Equal Society," adopted in 1999, the 21st Century COE Program launched the Gender, Law and Policy Center (GELAPOC) in 2003 with five main objectives: (1) to develop, as an emerging academic field, law and policy-related studies that focus on gender issues, (2) to strengthen the government's gender equality action plan with both theoretical reflection and policy-level solutions, (3) to provide resources and training for the development of educators and researchers with expertise in gender issues, (4) to become a privileged site of intellectual exchange and expert-level reflection for educators, practitioners, civil servants and lawyers, and (5) to act as a networking and information hub that promotes collaboration amongst scholars, researchers, students and decision-makers in Asian, European, and North American academic institutions.

The Center incorporates an inter-disciplinary approach to research focusing on the intersections of gender issues, law, and politics. Each of its researcher fellows is simultaneously engaged in social inquiry that focuses on one of three streams (Theory, Applied Research, and Policy Solutions), as well as upon one of six thematic research clusters (Political Participation, Employment and Social Welfare, the Family, Physical Liberty and Sexuality, Human Security, Gender and Education). These research clusters span a wide range of issues implicating both the public and private spheres, as well as topics of a domestic, comparative, and/or international nature. Each of the streams and research clusters is spearheaded by Japanese and/or foreign nationals employed as faculty staff, COE research fellows, and/or (post) graduate research assistants. The principle activities of the Center include the publication of books and/or results of ongoing research, library services, international academic exchanges, and organization of numerous research seminars, conferences and symposiums.

GELAPOC has had the privilege of developing a variety of collaborative relationships and academic/professional exchanges with overseas universities and institutions such as the Centre on Governance, University of Ottawa (Canada), the University of Paris, 7 (France), University of Milan (Italy), Ewha Womans University (Republic of Korea), and the Columbia Law School, Columbia University (United States), as well as with a variety of local municipal and prefectural authorities and professional lawyers associations in Japan. Internal to the university, the Center benefits from extensive inter-disciplinary collaboration with a rich diversity of faculties and departments, including the Faculty of Law and School of Law, the School of Public Policy, the Internet School of Tohoku University, as well as the newly founded Institute for International Advanced Research and Education. Finally, the Center has been pleased to support the realization of overseas research and fieldwork by offering short-term placements at its Paris and New York offices to associated faculty members, research fellows, and graduate students.

## **COE Office GELAPOC**

The Gender Law and Policy Center (GELAPOC) under the 21st Century Center of Excellence (COE) Program launched satellite bases which function as Japan's representative resource centers for gender law and politics/policy. These bases are expected to be vigorously utilized and achieve significant research and educational outcomes by linking and working with other institutions including local municipalities, bar associations, and national and international research centers.

The goals of these bases are: to realize gender equal society by 21st century Japan and the international community, by investigating necessary theoretical issues centered around studies of law and politics; to globally disseminate the outcomes of GELAPOC's research and education on gender law and policy; and to contribute to specific policy practices by making connections with local municipalities and legal associations, among others. GELAPOC, which conducts research in the same manner, is currently situated in a building that also houses El Sole Sendai, or the Sendai Gender Equal Opportunity Foundation, run by the city of Sendai. GELAPOC functions as an office of post-doctoral COE fellows, a network hub, and a library of gender law and policy, all at the same time.

From 1 March 2008, the COE office moves to Tohoku University Katahira Campus, continuing its reseach activities as a part of the School of Law (For new address, see the front page).

The Center had two overseas offices in Paris and New York from February 2004 to September 2007. They were frequently used by faculty, researchers and graduate students wishing to advance their research through exchanges with European, North American and international institutions and/or NGOs based in these cities.






